

ASSISTANT PROFESSOR OF TEACHING (Lecturer PSOE)

The Department of Population Health and Disease Prevention, Program in Public Health at the University of California, Irvine announces the availability of a position of ASSISTANT PROFESSOR OF TEACHING, formally titled Lecturer with Potential Security of Employment/Security of Employment (LPSOE/LSOE). Applicants should hold a PhD, DrPH, MD or equivalent degree, and will be expected to establish a vigorous teaching program in any area of public health, including integrative health, health policy, and global health. Candidates should possess excellent pedagogical, writing, and editing skills. Those with expertise in teaching critical thinking (including but not limited to statistics and study design) and writing about public health issues for various audiences are particularly encouraged to apply. This series requires, in addition to excellent teaching and service, the candidate make outstanding and externally recognized contributions to the development of his or her specific discipline and/or pedagogy. The successful applicant will be expected to play a leadership role in coordinating the undergraduate public health degree curricula; to oversee the undergraduate public health practicum program; supervise students in directed and independent study; contribute to the graduate professional degree program; and participate in departmental service activities.

The Program in Public Health at the University of California is fully accredited by the Council on Education for Public Health, with more than 1,200 undergraduate majors (BA and BS); approximately 50 students in the MPH program with concentrations in environmental health, epidemiology, sociocultural diversity and health, and biostatistics; and a PhD in Public Health with concentrations in global health and disease prevention. The successful candidate will be able to teach at all these levels, including large undergraduate lecture courses. The normative teaching load for this position is in-line with the specifications of the University of California Lecturer with Potential Security of Employment/Security of Employment (LPSOE/LSOE) series.

Review of applications will continue until the position is filled. The Department of Population Health and Disease Prevention recognizes the value of diversity in its faculty and encourages all qualified applicants to apply. Qualified applicants must have the demonstrated ability to work with a diverse group of colleagues.
